It will be held at the Ramada Inn (21000 NYS Rte. 3, Watertown, NY 13601 – (315) 788-0700). The Ramada Inn is just off Interstate 81 at exit 45 (coming from the south, turn left and stay in the left lane – it is the first driveway on the left).

Chaplains are called upon for a variety of important tasks: Invocations/Benedictions at banquets, dedicatory prayer/blessing of apparatus, planning a Memorial Service for a firefighter, and many other important responsibilities. However, one of the most challenging tasks we

I'm pleased that **Dr. Ryan N. Fraser**, Ph.D., LCPT will be our presenter/trainer. Dr. Fraser is a tenured Associate Professor of Clinical Mental Health Counseling at Freed-Hardeman University in Henderson, Tennessee. He has been teaching in the graduate counseling and undergraduate psychology programs since 2006. He teaches a wide spectrum of courses, which focus on challenging topics including crisis intervention and counseling, grief care and counseling, depression and anxiety management, and many more.

After we spend six hours of training with Dr. Fraser, we will then participate in a training where we will use the tools we have learned in a role-playing situation. On Wednesday morning, we will hold a debriefing and a time for questions with our trainer. I'm hoping it will be a very helpful practical training that we will never have to use (but we will be prepared when the crisis arises).

It has been a challenge to secure funding so that we can keep the costs affordable. Over the last several years, a few conferences have brought in some revenue to the association and at other times, they have been a financial strain. The cost of this conference for Fire Chaplains is less than many of the other associations around the state, but it is not as low as I would have preferred and for that – I'm sorry.

As you will see on the agenda, our annual meeting will be held at 7:00 PM on Sunday evening. Once you settle in to your room at the Ramada, there are plenty of choices for restaurants nearby. Bob Evans is only 100 feet away, with Red Robin, Long Horn Steak, Panera Bread, Red Lobster, Texas Roadhouse, Olive Garden, TGIFridays, Tully's, IHOP, Buffalo Wild Wings, Five Guys, Chipotle Mexican Grill, Sonic, Chinese Buffet, Denny's, Applebees, Cracker Barrel, Japanese Steak House, McDonald's, Arby's, Taco Bell, and a locally owned Coca-Cola theme diner called Shorty's Place, all within 1.3 miles.

Events are still being finalized for the spouses, but at present we have some time for shopping planned, a possible speaker and a special "Paint & Sip" event hosted and sponsored by Lynnette Lundy-Beck and Director Emeritus Chaplain Samuel Canon Lundy. The conference ends with lunch on Wednesday. If you will be leaving before lunch, please indicate that on the registration form so I will be able to get your certificate to you.
